

# **September Meeting Minutes**

Minutes of the OARC General Meeting - September 2. 1998

The meeting was called to order by the (new) President, Ed (VA3MPY). at 7:30 p.m.

Ed welcomed several guests this evening, including Guy (VA3FZA), John VE3VGI and Elizabeth Duncan, who came to the meeting after checking out the OARC web site (and a fine site it is). Elizabeth is interested in becoming a licensed amateur. (Good luck Elizabeth!)

Reflecting the energy obviously stored up through the sEummer. Ed set a very business-like tone to the proceedings. maintaining it through-out the evening. Machine-gun like, a rapid series of preliminary announcements were made, including: Dean (VA3CDD) was accepting new/renewed memberships, Brian (VE3ZRK) had brought some 75 ê cable. in case someone wanted it. Fred (VE3IO) thanked Russ (VE3LOW) for help fixing his broken beam and George (VE3BNO), the OARC Club Historian, was looking for old Club records of days gone by.

Fully aware of what was on everyone's mind and quite prepared to have members savour the moment. Ed showed a deft hand as he allowed the pace to slow when turning to Flea Market organizer Jim (VE3XJ) for an update. Preliminary data (later born out to be true) showed a great deal of vendor interest. As of the meeting. 28 tables were sold, including tables to 6 commercial vendors. Mike (VE3FFK) announced that the next Emergency Measures meeting would be October 3rd at the RMOC building.

Ed. adding an announcement of his own. indicated that on November 3rd, on VE3MPC at 7:30 pm, there will be a special net in commemoration of the 125th anniversary of the RCMP. Special certificates and pins would be available to those who check in.

Doug Leach (VE3XK) representing RAC brought a copy of RAC's new operating manual which would be made available from vendors at the Flea Market. Ken (VA3KA) reminded members that the ARRL VHF contest was slated for the Labour Day weekend.

Fred related his problems (and expenses) repairing a computer monitor. Also, Fred continues to offer his Zenith TV to a good home.

Jim explained he was planning to attend a disaster planning session on the West Coast. which would also include amateurs' participation in the Ice Storm. Jim was looking for interesting stories and anecdotes. Ed again took possession of the floor with an announcement that the Canadian Police College was going to be offering a free radio amateur course this Fall (here you go Elizabeth!) It is slated to start in October and will run to May. Ed also mentioned that there is some thought being given to a Code-only course.

Not to be on the sidelines for long. our new VP Rick (VE3IHI) showed his typical fine form with interesting tid-bits of information of his own. A letter from AMSAT was received, thanking the OARC for its 175 USD donation. Based on preliminary data (yet to be officially confirmed), the West Carleton Club beat out the OARC on Field Day (3110 vs 2912 points). The WCC unashamedly capitalized on an OARC computer failure, occurring in the middle of the night, to squeak ahead. In a nutshell, this means that there will be no pies this year. Rick read out a letter received from Bytown Marine announcing that an anonymous donation in the amount of \$2,500 has been made to the OARC, to be held in an account by Bytown. (The entire text of the letter was reprinted in the September edition of the Groundwave.) (Note from your Minute Taker: On behalf of all the members, we sincerely thank the donor and Bytown Marine for this extraordinary generosity.) Rick reported that based on his discussions with other clubs who had met with Industry Canada on their licensing proposal, this is a fruitless exercise, and in his opinion, not worth exploring. Rick indicated that he is always open to guest speaker ideas from the members.

With that last announcement, Rick introduced the guest speakers of the evening, Paul Cooper (VE3JLP) and David George (VE3UOL). who spoke on the activities of the newly formed Capital DX Club. The next meeting was scheduled for Monday. September 14th at 7:30 pm in the Board Room of CFRA. Additional information may be obtained from Paul (pcooper@fox.nstn.ca) or Dave (ve3uol@rac.ca).

Resuming the chair. Ed indicated that our outgoing Treasurer. George, is looking for someone to audit his books before they are passed to the new Treasurer. Elizabeth Johnson (VA3ELB). On a sad note. Ed advised everyone of the passing of a long standing member Doug Burrill (VE3CDC). Our sincere condolences to Doug's family and friends.

Ken related to members an article he read reviewing a new transceiver with built-in modem and GPS. and that will multiplex voice and data. (We'd all want one of those under our Xmas trees, Ken.) Keeping it in the family. Anne (VE3TSB) won the evening's 50/50 draw. On that note. Ed ended what was a very full meeting at 9:20 pm with members retiring to coffee and swapping tails of their summer adventures.

Subject: RAC encouraged by CARAB discussions

Radio Amateurs of Canada met with Industry Canada officials at a meeting of the Canadian Amateur Radio Advisory Board on September 11th, and discussed several issues of concern to Canadian Amateurs.

Prominent among the matters on the table was a proposal themselves available and a shift roster was set up for for the streamlining of the Authorization process by Industry Canada in which the Department would drop the requirement of a station licence, and eliminate the annual renewal fee of \$24.

RAC raised a number of concerns related to the maintenance of a database of addresses of amateurs, the portability of callsigns and the ability and willingness of the department to monitor and enforce the application of the Radio Regulations.

.RAC representatives were encouraged by the positive response received from IC officials and it is their sincere expectation that many of the concerns expressed by amateurs are being taken seriously and hopefully will be addressed in a manner which will be mutually satisfactory.

Subject: Swiss Air Crash - Radio Amateurs Respond

Within approximately 2 hours after the Swiss Air crash. the Emergency Measures Co-ordinator, for Halifax Regional Municipality Barry Manuel initiated a call-out to members of the HRM - EMO Amateur Radio Group. The call was initiated through Dave George (VE1AJP) who is the contact for EMO and RAC ARES Coordinator for the Halifax area. The Director of the Nova Scotia Region. Canadian Red Cross, John Byrne actived the Disaster Response Team (DRT) including the Telecoms Officer (VE1CH) and directed us to report to the site and join the ERV at that location.

Amateurs were dispatched to the Command bus at Peggy's Cove and were asked to establish telecommunications between the site and a net control station downtown. Amateurs were also sent to CFS Shearwater and to several other staging areas which were subsequently moved or closed down as more accurate information filtered in. Our emergency ID cards and vehicle identification cards were IMPERATIVE to gain access to both the outer and inner perimeter.

As Telecommunications Officer for the Canadian Red Cross, VE1CH called in members of the Senior Amateur Radio Association to activate the communications centre at the Canadian Red Cross Headquarters in downtown Halifax and also set up telecommunications links (amateur and other) between the on site Emergency Response Vehicle (ERV) of the Red Cross. the Command Post. Red Cross HQ and the net control station.

Amateurs at the Command Post were kept very busy interfacing between the on-site commander, the military and just about everyone else who the site commander needed to talk to. Approximately 20 amateurs made

twenty-four hour operation by the network control station. Two repeaters were used in the operation . one for traffic handling, the other for personnel coordination and assignment.

Amateur operators were also asked to provide emergency HF links to the military and naval ships engaged in the search and were also asked to establish communications on marine emergency frequency of 156.8 Mhz.

The response was both fast and efficient considering the hour and the number of people needed. The entire operation was moved from the Blanford area near Hubbards, to Peggy's Cove when the exact position of the debris field became known.

the extensive training provided to members of the HRM-EMO team over he past year really paid off. Radio procedures were excellent and I heard MANY reports from senior officials at the site how well the amateurs performed.

By the time it lands here I expect it to cost around 2000 CDN to do this.

I would further like to propose that the OARC ask the Ottawa Public Library to accept these documents as a gift from us, and added to their reference holdings for public access. This means anyone would be able to use them in the library, make photocopies, etc., but they would not circulate. This gift should be acknowledged in some small way, such as a note on the box holding the documents.

I think this proposal fulfills several of the objectives of the fund originator, specifically the following.

# **OARC Fleamarket Report**

The following are the financial results of the flea market.

The flea market had three sources of income. Those sources of income came from the admission fees, table and tailgating fees and concessions, summarized in the following table:

| Tables and tailgating | \$260.00        |  |
| Concessions           | \$270.50        |  |
| TOTAL                 | \$1.532.30      |  |

In addition, an advance of \$650 was issued by the Treasurer. However, expenses were \$192.37. These expenses included the soda pop, coffee, condiments. BBQ tools and utensils, ice, sundries and a storage box to store these items for next year. Therefore, a cheque in the amount of \$1.989.93 is being submitted to the club (the result of the total income less my expenses plus the advance).

There were other expenses not included in this report. The advertisement in The Canadian Amateur was \$270. In addition, the hall at the carp Agricultural Society was \$250. Finally, the club owes Rick, VE3IHI, about \$41 for signs. Accordingly, the profit to the club is in the order of \$812. This figure is about nine times greater than the profit made last year.

As result of these figures, we can say that the flea market was a great success this year.

Special thanks to all those who volunteered their time and efforts.

## Joe Norton Award

Joe Norton Trust Award for Amateur Radio

The OTTAWA AMATEUR RADIO CLUB INC. awards annually the Joe Norton Trust Award for the advancement of amateur radio. The amount of this award is approximately \$500

#### ELIGIBILITY

To be eligible, a candidate must:

- 1. Be a resident of the National Capital Region as defined by the official federal government map:
- 2. Have received a Certificate of Proficiency in radio from 1998. Industry Canada during the period June 1, 1996 to June 1,
- 3. Send a written submission of no less than 600 words and no more than 900 words to the executive of the OTTAWA AMATEUR RADIO CLUB INC., setting out his 10. The award will be made during the regular meeting of or her interests, achievements and plans to contribute to the advancement of amateur radio: and
- 4. Present him/herself for an interview if so requested by the judges.

#### RULES

- 1. Entries must be received on or before October 14, 1998. 1998 to: Joe Norton Trust Award No entries received after that date will be considered.
- 2. The club will send an acknowledgment in writing upon OTTAWA AMATEUR RADIO CLUB INC. receipt of an application.
- 3. A panel of judges appointed by the executive of the OTTAWA AMATEUR RADIO CLUB INC. will evaluate all

4. Finalists may be interviewed by members of the executive of the OTTAWA AMATEUR RADIO CLUB INC., the panel of judges. or both.

- 5. Submissions will not be returned.
- 6. If the judges do not select a candidate in any year, no award shall be made in that year and the monies shall return to the trust fund.
- 7. All decisions of the executive of the OTTAWA AMATEUR RADIO CLUB INC. are final.
- The winner will be notified on or before October 24.
- The winner will notify the OTTAWA AMATEUR RADIO CLUB INC. of his or her acceptance of the award no later than October 31, 1998.

- 11. The winner agrees to have his or her name. photograph and address published in club bulletins. trade papers and magazines, and on the airwaves.


